# A Message from Good News

## Going to Nairobi and Charlotte



Tom Lambrecht and I will leave on April 7 for a quick trip to Nairobi, Kenya, to meet and strategize with 125 African delegates to the

upcoming General Conference. When I say "quick," I mean "real quick!" Our trip will take just shy of five days from the time we leave to the time we return. We made this same trip last September. In total about 120 hours – and almost half of that time will be spent traveling. If this were a movie, I'd be shaking my head and saying something like, "I'm getting too old for this!"

A few weeks ago, United Methodist News Service ran an article reporting that Good News plans to be at the General Conference in Charlotte (April 23 – May 3.) The reaction by some United Methodist pastors and others on social media was predictable. "Disaffiliation is over. Good News should be gone by now and let the UM Church move on."

But how can disaffiliation be over when it was never permitted to begin for the majority of United Methodists who live outside the United States? Paragraph 2553, which allowed churches in the U.S. to exit, was ruled by the bishops not to apply to congregations overseas. Claiming that disaffiliation is over because the window has closed here shows just how little "centrists" and progressives think of our brothers and sisters in Africa, Asia, Europe and the Philippines.

If the General Conference votes not to allow churches outside the U.S. the opportunity to consider disaffiliation, it will send a clear message to our friends in Africa and the Philippines – that the UM Church is comfortable granting rights and privileges to churches in this country that are primarily wealthy and and white and that it will not provide for churches in the developing world that are primarily poor and people of color.

Why are Tom and I headed to Africa and why is Good News going to Charlotte for the General Conference? Because we want to stand with our African brothers and sisters. Because we believe churches outside the U.S. deserve justice. Because we have a debt to pay. Delegates from all over the world came to General Conference after General Conference to join us in contending for the faith once and for all delivered to the saints. They and God's grace are the reason disaffiliation was passed in the first place. They didn't abandon us when we needed them. And there is no way that we will abandon them when they need us.

Please pray for Tom and me, for our brothers and sisters around the world and for the General Conference. And thank you for your continued, generous support of our work.

#### **Extending Disaffiliation Options**

The main agenda items for the Renewal and Reform Coalition at the 2024 General Conference meeting in Charlotte, NC, April 23-May 3 relate to providing new disaffiliation pathways for churches and annual conferences that have not been offered a fair opportunity to disaffiliate so far. This will be an uphill battle. United Methodist bishops and other leaders want to turn the page on disaffiliation and put it behind them. UM leaders are aghast at the high number of congregations that have disaffiliated in the U.S., particularly in the South and Midwest. They do not want to lose any more.

So, the UM establishment is putting on a full-court press to prevent any more disaffiliation pathways from being enacted at the 2024 General Conference.

United Methodists outside the U.S. have not been allowed to consider disaffiliation under the Par. 2553 pathway provided by the 2019 General Conference. This arbitrary decision, made by bishops without obtaining a ruling from the Judicial Council, has disenfranchised the majority of the church that lives outside the U.S.

The failure to allow non-U.S. churches to disaffiliate and the imposition of draconian costs on churches in the U.S. amounts to coercion. A coerced covenant is no real covenant at all. Hopefully, the 2024 General Conference delegates will consider fairness and provide the needed opportunities for realistic disaffiliation that have been lacking outside the U.S. and in some conferences in the U.S.
